### ESTIMATED COST OF COURSES INCLUDING TUITION, FEES, BOOKS, SUPPLIES, AND OTHER ADDITIONAL COSTS.

The cost of attendance is an estimated total amount which will vary depending on your living situation (whether you live with your parents or off campus) and residency status (California resident or non-resident). The Financial Aid Office is designed to assist qualified students in obtaining grants, scholarships, and federal work-study funds for educational expenses. Students are encouraged to apply for financial aid, maintain enrollment, and meet the Satisfactory Academic Progress (SAP) Standard. Your final cost is dependent on your VA educational benefits, books/supplies, and monthly housing allowance (MHA).

\*Only **Chapter 33** recipients may be entitled to a percentage of the following VA Educational Benefits based on

your length of service:

- Monthly housing allowance equal to the basic allowance for housing payable to a military E-5 with dependents, in the same zip code as your school (paid to the student and prorated based on training time and the eligibility percentage)
- Yearly book and supply stipend of up to \$1000 per year (paid to the student @ \$41.67 per unit and prorated based on the eligibility percentage).

#### **INSTITUTIONAL FINANCIAL ASSISTANCE VETERAN STUDENTS SHOULD APPLY FOR:**

Students using VA education benefits are encouraged to apply for financial aid online at [Student Aid-FAFSA](#) to be considered for federal, state, and institution grants and scholarships. Financial aid can be used along with VA veteran education benefits. The LASC code to file the FAFSA application is **007047**. #### **ESTIMATED AMOUNT OF STUDENT LOAN DEBT UPON COMPLETION OF A DEGREE OR CERTIFICATE AT LASC:**

For many students, borrowing to finance their college degree is necessary. While student loans may be essential to finance your degree, students need to borrow responsibly. This means only borrowing what you need. Students may borrow (if eligible) between \$5,500 to \$10,500 per year, depending on their school grade level and dependency status. #### **TRANSFER CREDITS INCLUDING MILITARY CREDITS**

Students receiving VA education benefits are required to submit their college transcripts/military transcripts (JST's) no later than the end of their first semester. Students must have their transcripts evaluated by the veteran's counselor, who will determine which courses apply to their educational goal. #### **REQUIREMENTS FOR IN-STATE TUITION INFORMATION**

Several state and federal laws provide exemptions from paying nonresident tuition for current and former members of the U.S. *Armed Forces* (Montgomery GI® Bill–Active Duty program (Chapter 30), the Veterans Readiness and Employment program (VR&E - Chapter 31), the Post-9/11 GI® Bill program (Chapter 33), or Dependents Educational Assistance (DEA - Chapter 35), and their *dependents*. #### **ENROLLMENT CERTIFICATION**

After signing up for classes on the students current Veteran Student Educational Plan (VSEP), students must submit a certification request every semester to prevent any delays on monthly allowance. The Certification Request form is available on [LASC's Veterans Resource Center](#) website under the "IMPORTANT INFO & FORMS" tab.

## ABSENCE DUE TO MILITARY SERVICE

A student who is an active duty or reservist of the United States military, and who receive orders compelling a withdrawal from courses, should contact the Admissions and Records Office, to request a Military Withdrawal (MW), with proof of such orders to receive a full refund of those courses (For Chapter 33 students, the school will return the tuition and fees to the VA). An "MW" symbol will be assigned and will not be counted in progress probation, dismissal calculations, or in calculating the permitted number of withdrawals a student is allowed. Student can resubmit the application for admission upon return. Students who are receiving the VA benefit along with financial aid should be aware that withdrawing from a course(s) will have an impact on their benefit/financial aid status. Students are strongly encouraged to talk to the Financial Aid Department. VA benefits will stop as of the drop date reported for all classes.

If you are a Cal Grant recipient and have been called to active military duty or are entering military service, you may apply for a deferment of your Cal Grant for up to three years. Send the [Military Deferment Request Cal Grant Programs form](#) to the California Student Aid Commission, along with a copy of your orders.
